ILLCIT DISCHARGE DETECTION AND ELIMINATION

During the permit year, the Kane County Division of Environment & Water Resources continued to update the County storm sewer mapping throughout the unincorporated areas of Kane County. Storm sewers, culverts, roadside ditches, channels, and drain tiles have been added to the mapping system.

CONSTRUCTION SITE RUNOFF

Construction site stormwater run-off within Plato Township is regulated by the Kane County Stormwater Management Ordinance which was adopted by the Kane County Board. The Ordinance is enforced in unincorporated areas and non-certified communities within Plato Township by the Kane County Water Resources Department.

POST CONSTRUCTION SITE RUNOFF:


Post-construction stormwater management in new development and redevelopment areas within Plato Township is regulated by Kane County Stormwater Management Ordinance with was adopted by the Kane County Board. The Ordinance is enforced in unincorporated areas of Plato Township by the Kane County Water Resources Department.
